

INFORMATION applicable to CCTV

Taking into account the provisions of Regulation (EU) 2016/679 of the European Parliament and of the Council of 27 April 2016 on the Protection of Natural Persons with Regard to the Processing of Personal Data and on the Free Movement of such Data, and Repealing Directive 95/46/EC (Hereinafter: GDPR), in connection with the possibility of movement of persons on the area of the enterprise of SUPRAVIS GROUP Spółka Akcyjna with registered office in Bydgoszcz, we inform that:

- 1) the controller of the provided personal data in the form of the image recorded in the CCTV records is SUPRAVIS GROUP Spółka Akcyjna with registered office in Bydgoszcz, ul. Nowotoruńska 56, 85-840 Bydgoszcz (Statistical Number (REGON): 090491090, Tax Identification Number (NIP): 5541000184), registered in the Register of Entrepreneurs of the National Court Register under number 0000293647; telephone (52)3268800 , e-mail: administrator.danych@supravis.pl;
- 2) the provided personal data (image) shall be processed for the purposes of securing of legitimate interests of the data Controller (art. 6 section 1 point f of GDPR), i.e. limiting of the access to the area of the enterprise as well as ensuring security and safety of employees, persons and property. Provision of the data shall be voluntary, yet a refusal to provide the personal data shall result in a refusal to allow for entering of the area of the enterprise;
- 3) the area of SUPRAVIS GROUP Spółka Akcyjna is covered by CCTV. Processing of the personal data by means of the CCTV system shall cover the buildings and the external area;
- 4) the provided personal data (records from the CCTV) shall be processed by the data Controller solely for the purposes, for which it has been collected, for the period not exceeding 3 months from the recording date. This period may be extended in case when the records of the image constitute evidence in proceedings conducted on the basis of the law or SUPRAVIS GROUP Spółka Akcyjna learns that they may constitute evidence in such proceedings. In such situation, the period of processing of the records shall be extended to the time of legally valid completion of the proceedings.
- 5) the processed data may be transferred to entities performing the security service in relation to the facilities of the Company upon the order of the Controller;
- 6) in relation to the provided personal data, the data subject shall have the right to:
 - access the provided data,
 - request data rectification,
 - request erasure or restriction of processing of the data,
 - object to the processing,
 - data portability,while it shall not be possible to erase or restrict processing of the data in the extent, to which the processing is required by the provisions of the generally applicable law. Moreover, if the data is processed on the basis of a consent, the data subject shall have the right to withdraw the consent to data processing, with the reservation that the withdrawal of the consent shall not affect lawfulness of the processing performed on the basis of the consent before its withdrawal.
- 7) in case when the data subject thinks that law has been violated in the field of processing of the provided personal data, they shall have the right to lodge a complaint to the President of the Personal Data Protection Office.
